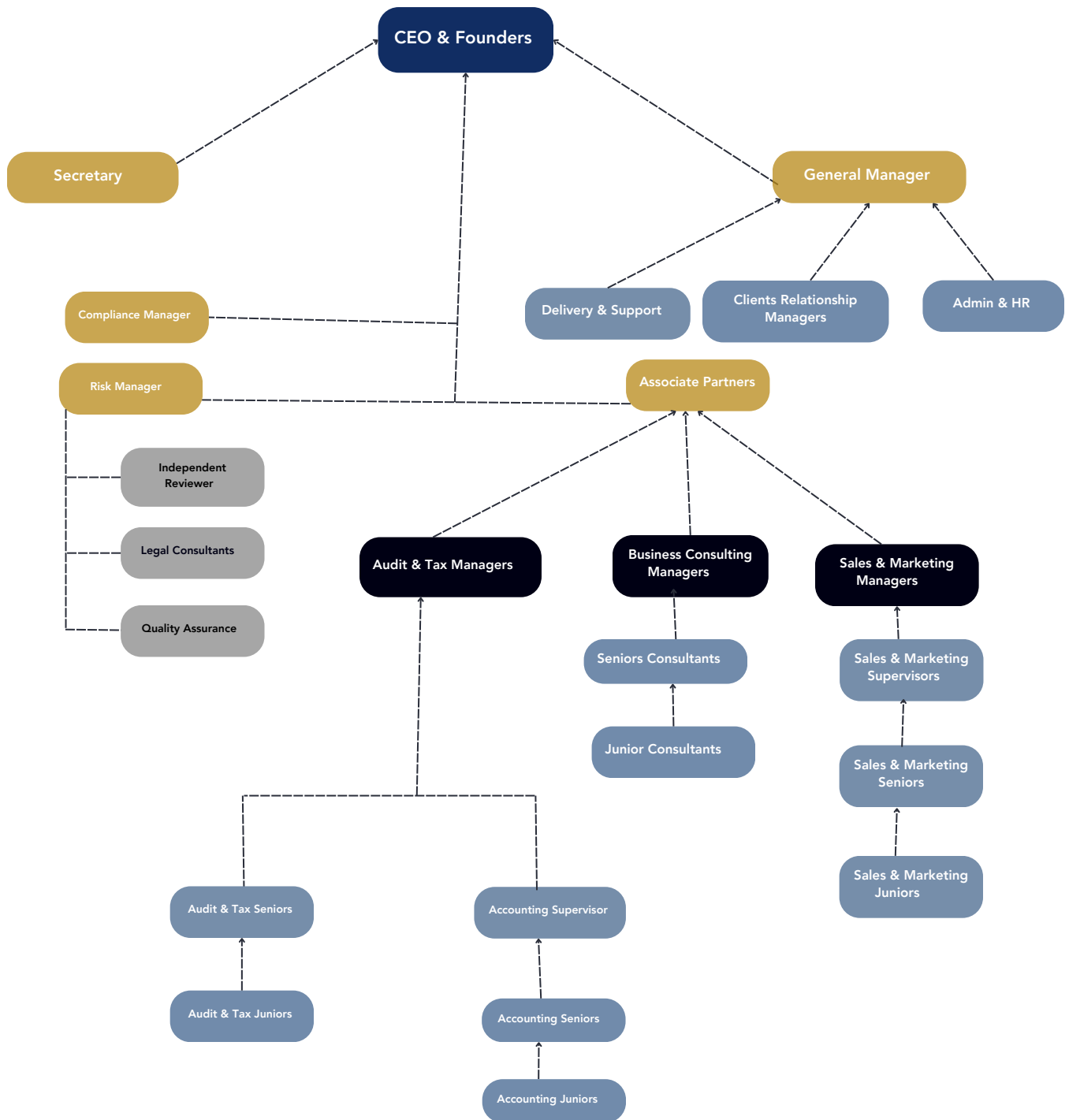

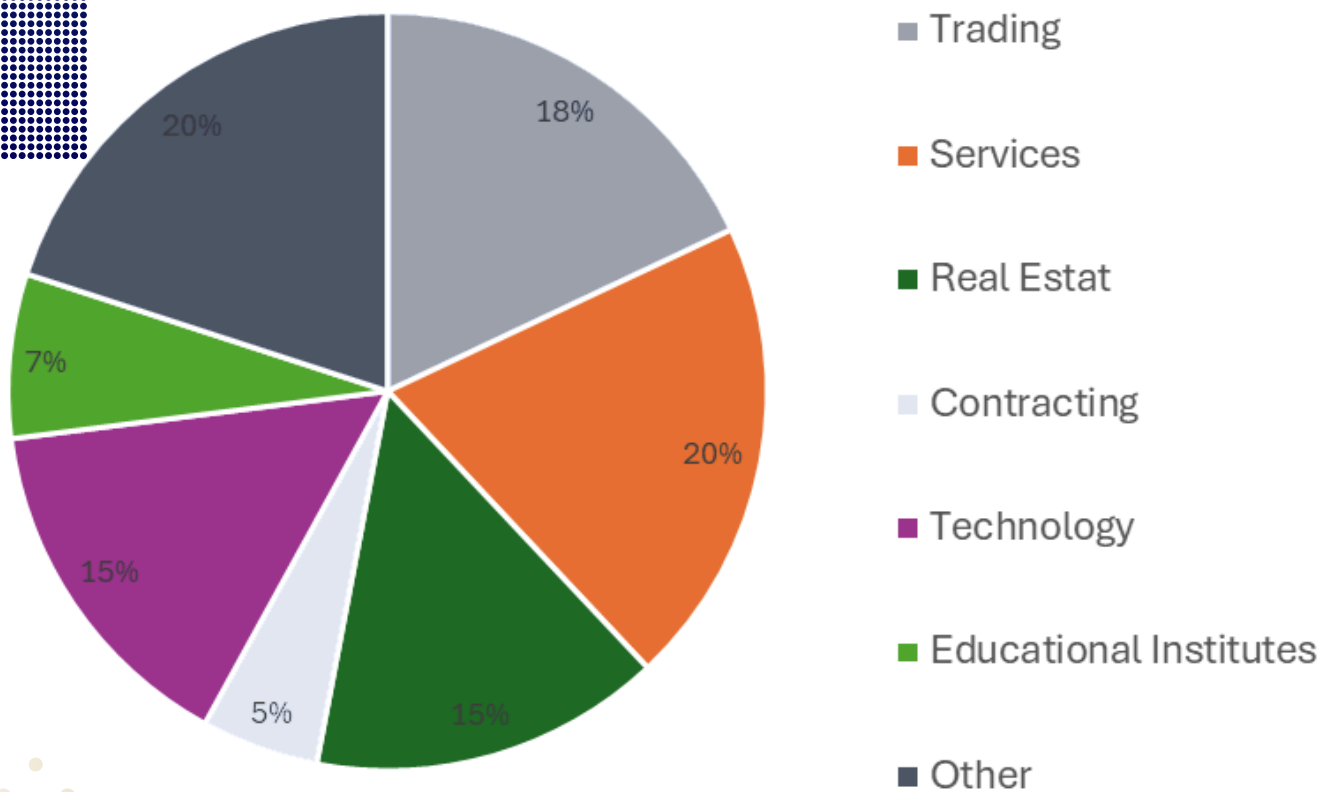

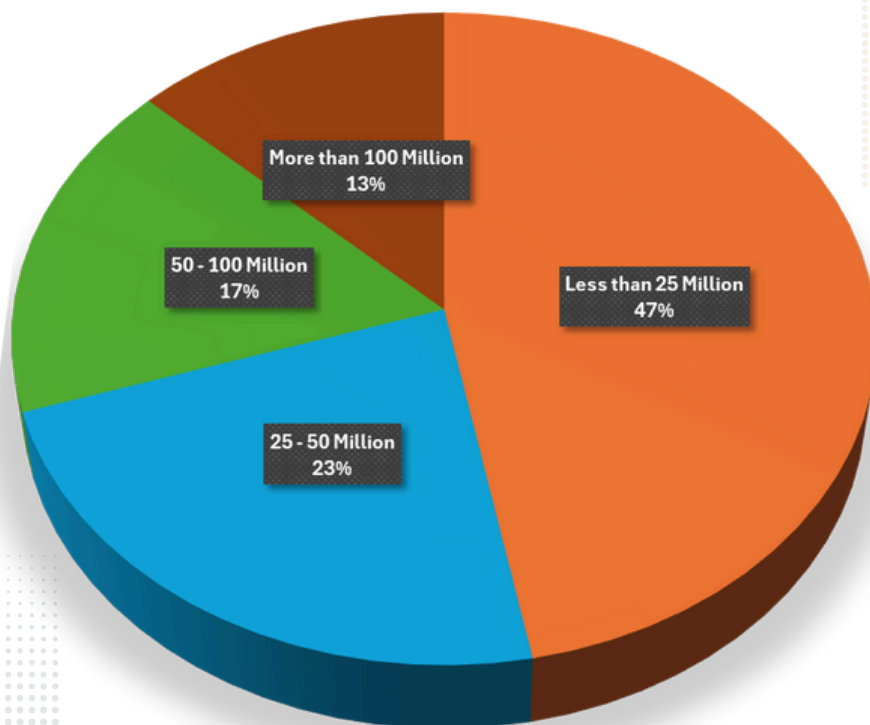

Our Client Portfolio By Turnover (in AED)

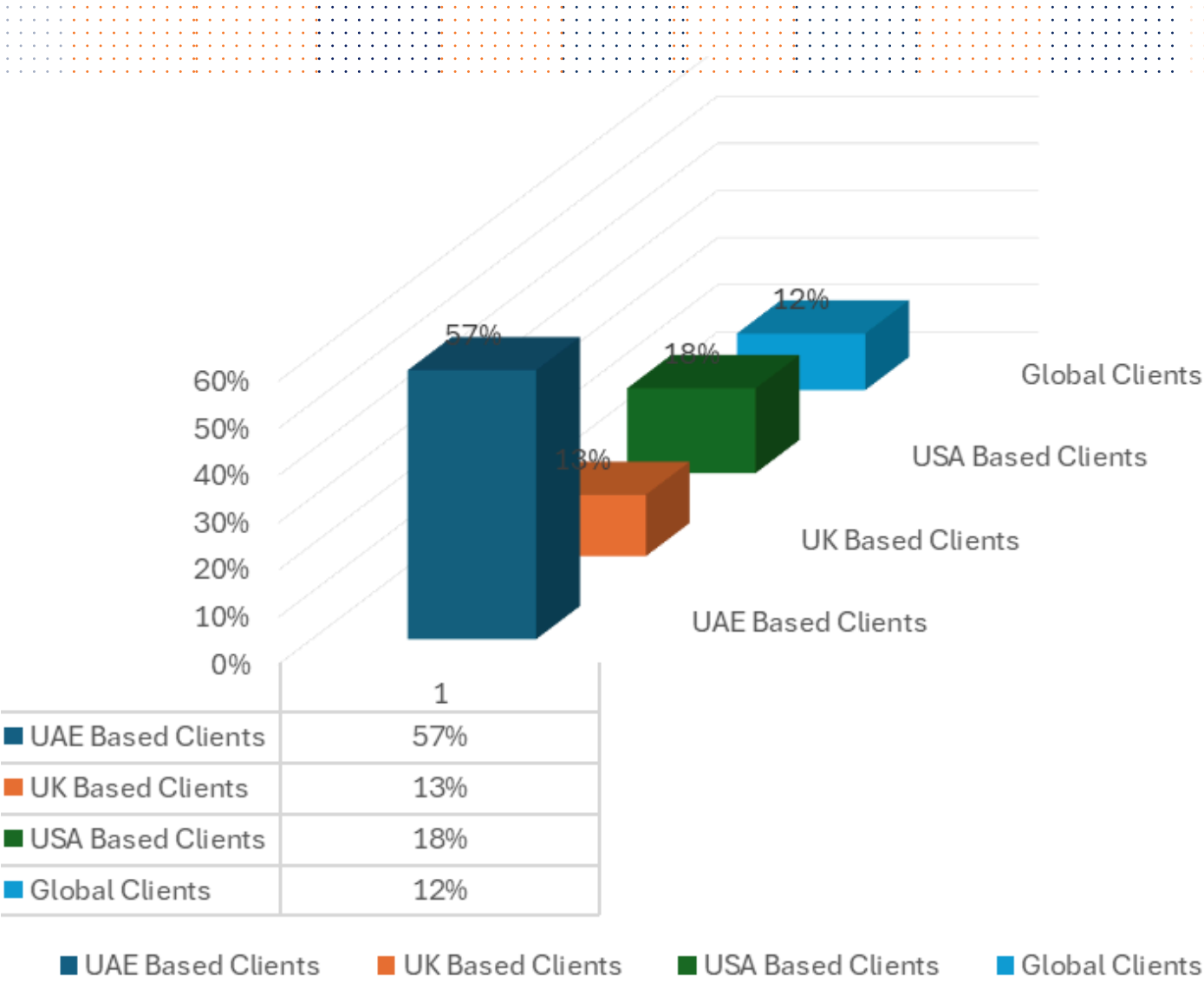
